4. I NDEPENDENCE

The Red Crescent is an independent organisation. While its national Societies work closely with the aithorities in their respective countries and abise by their laws, they maintain the independent pursuit of international principales of the Red Crescent and Red cross Societies.

5. CHARITABLE NATURE

The Red Crescent is an charitable organisation offering voluntary help and relief when needed without seeking any financial reward.

6. UNITY ASPECT

The Red Crescent may not establish more than, one organisation in each country and its humanita rian deeds extend to the entire nation.

7. GLOBAL CHARACTER

The Red Crescent Societies are global organis ations witch enjoy equal right and promote co-ope ration and understanding among them.
